CFPD Radical Ally Award - CFPD would like to recognize partners who have collaborated to create outcomes for people with disabilities that no one individual or agency could accomplish alone. It's more than simply two or more components working together; true collaboration happens when shared knowledge, talent and resources meet, creating an entirely new view that no one partner could achieve without the other.

CFPD Voice For Impact Award - CFPD would like to recognize an individual or family member of an individual affected by disability whose advocacy has significantly impacted lives or conditions for people in Colorado. Disability advocacy is acting, speaking or writing to promote, protect and defend the human rights of people with disability. Advocates may advocate for themselves, another person, or a group of people with disability. They work through issues that have an adverse impact on rights for an individual or group, or on a society-wide level.

## The Linda Chism-Andre Lifetime Trailblazer Award

Honoring lifetime contributions, tireless activism, informed compassion.

Linda Chism-Andre spent her life advocating. A person affected by disability from childhood, one might think Linda used her sharp mind and clear voice to make her world a better place. But it was never just her world she wanted to change.

Linda managed her conditions and her life without complaint. If she thought that anyone else might benefit from her difficulties navigating the world as a person with a disability, though, Linda was never silent. She worked to eliminate barriers - literally and metaphorically - making the world she left better than she found it.

Her work with Atlantis Communities spanned decades, as Linda fought for, embodied and promoted their most basic mission, assisting "the individual in fulfilling whatever goals they outlined for themselves."

Her action and advocacy as a member of Denver's Gang of 19 changed how public transportation works for people with disabilities forever for the better.

And she will be remembered fondly by all who knew her as a friend, advocate, mentor and inspiration.

We're dedicating our $25^{\text {th }}$ Anniversary Action Awards event to Linda, and creating an award category for other lifetime trailblazers like her. Help us recognize and award another of Colorado's historic disability advocates.
